#### A blueprint for a European degree

EU education ministers have agreed on the roadmap and the criteria for awarding a joint European degree (ED) label within the European Higher Education Area (EHEA). This additional certificate would be open to programmes delivered jointly by universities from different countries including at least two EU member states. This is potentially the first step towards creating a new type of European degree. The joint European degree will be rolled out in three phases starting in 2026. The following two years would be spent evaluating the label and exploring the feasibility of a fully-fledged degree. Based on this evidence, Member States may decide in 2029 on whether to introduce the full degree or not. The package includes recommendations on a European recognition and quality assurance (QA) system, and attractive/sustainable careers, to ensure that national higher education systems address the uneven recognition of the diverse roles staff take on in addition to research.

Education is largely a national competence and an earlier survey of ten Erasmus+ pilot projects has revealed obstacles to the introduction of European joint degrees including incompatible national rules on curriculum structure, duration, teaching languages, and recognition of blended and online learning. However EHEA does not have a specific budget and taking part in the European degree is on a voluntary basis. Stakeholders are highlighting the need for additional budget to the Erasmus+ programme to develop joint degrees.

# **European Commission**

#### **Horizon Europe Work Programme 2025**

The European Commission is investing over €7.3 billion through its newly adopted Horizon Europe work programme for 2025. The calls, topics and actions will be published on the Funding & Tenders Portal in due course.

#### **MSCA Ukraine**

The Commission has updated the Marie Skłodowska-Curie Actions (MSCA) 2023-25 work programme providing an extra €10 million to support Ukrainian scientists and to launch a new MSCA 'Choose Europe for Science' pilot, with opportunities for early-career researchers, including competitive allowances and longer contracts. This pilot is part of the wider 'Choose Europe' initiative.

#### Work programme Cluster 1: Health

The first part for the Health Cluster under Horizon Europe's new strategic plan for 2025-2027 is published with indicative budgets for the various calls including deadlines for applications. It aims to align with the European Commission's Political Guidelines for 2024-2029, with a focus on healthcare resilience, leveraging biotechnology, and artificial intelligence, supporting the development of critical medicines and strengthening societal preparedness and response. In 2026-2027, the Health Cluster will pursue the following priorities:





- · non-communicable diseases, including mental health;
- environmental impact on human health and healthcare systems;
- · pandemic preparedness and response, including AMR;
- · sustainability and efficiency of Europe's healthcare systems;
- digitalisation in healthcare through health data and data-driven approaches, including AI;
- innovative tools and critical technologies including AI, for topics ranging from predictive biomarkers of disease progression to biomedical research and regulatory testing.

The Health Cluster will also address the empowerment of specific populations, such as disabled persons and their families.

#### **FP 10**

The next Framework Programme (FP) for research and innovation is expected to remain independent but connected to European Competitiveness Fund, according to reports after the speech of European Commission president Ursula von der Leyen at the annual EU budget conference. The assumed rationale is that such connection will provide coherence in investment and address current fragmentation, overlaps, and gaps among existing programmes – such as Horizon Europe, Digital Europe, the European Defence Fund etc. However the nature of that connection is still to be defined.

#### SNS JU in Health

The Smart Networks and Services Joint Undertaking (SNS JU) will dedicate €24 million to large scale "Trials and Pilots with Verticals" (Stream D) to accelerate vertical sector adoption of advanced connectivity technologies in health among other sectors e.g. 6G connectivity platforms. The objective is to shift the focus toward an in-depth exploration of specific challenges – so-called "pain points" – within individual vertical sectors and co-develop and demonstrate solutions to address concrete adoption barriers. An amended SNS JU R&I Work Program 2025 will be published in due course in 2025.

# **European Medicines Agency**

#### First treatment against severe thyroid eye disease

The EMA has recommended EU approval of Tepezza (teprotumumab) for treating moderate-to-severe thyroid eye disease (TED), a rare autoimmune condition causing eye bulging, pain, and vision issues. The CHMP's opinion now goes to the European Commission for final approval, followed by national pricing and reimbursement decisions.

#### Data and AI in medicines regulation to 2028

The EMA and the Heads of Medicines Agencies (HMA) released a joint work plan on using large volumes of regulatory and health data, and AI to enhance medicines regulation. The work plan aims to enable efficient discovery, access, and use of the network's data assets through cataloguing and strengthening data quality, starting with real-world data, adverse drug reaction data, and medicinal product master data, the core data needed for the operations of the network. Key initiatives include supporting EMA's scientific committees and the pharmaceutical industry in evaluating AI through the medicines lifecycle, developing guidance on AI in clinical development and in pharmacovigilance, fostering EU-wide and international collaboration, and providing the network with training on AI and a framework for sharing and collaborating on AI tools. A new strategic advisory group, the Network Data Steering Group (NDSG), will oversee the implementation of the work plan. NDSG combines the former Big Data Steering Group and the Network Data Board.

#### Tackling vulnerabilities in the supply chain of radiopharmaceuticals in EU

The EMA and HMA have issued recommendations to address radiopharmaceutical supply chain vulnerabilities due to limited EU production and reliance on third-country materials. Suggestions include boosting EU capabilities through:

- initiatives like the European Observatory on the Supply of Medical Radioisotopes; the Strategic Agenda for Medical Applications of Ionising Radiation (SAMIRA) and the European Radioisotope Valley Initiative (ERVI);
- improving aging infrastructure;
- enhancing production facilities, such as nuclear reactors;
- addressing transport challenges through harmonisation of certification procedures and standards across different countries.

## Across the World

#### **UK to rejoin Erasmus+**

The UK and EU have agreed on the UK's return to the Erasmus+ programme starting in 2025. This decision reinstates student and staff mobility between the UK and EU member states, facilitating academic exchanges, research collaborations, and vocational training opportunities. The move aims to strengthen educational ties and promote cultural exchange, reversing the post-Brexit exclusion.

#### IHI draft documents on forthcoming Call 11

The Innovative Health Initiative (IHI) has published draft information on future call topics ahead of the official call launch to give applicants additional time to find or build a consortium. The draft topics are still under development and the texts may change considerably between the versions published here and the call launch. Please check the final topic texts once the calls are launched. The following topics are under consideration for inclusion in IHI call 11, a two-stage call scheduled in Q2 2025:

- Towards precision medicine: platform for transdiagnostic stratification of brain dysfunction
- Understanding how infections foster and induce noncommunicable diseases
- Al-powered signal detection in pharmacovigilance
- Leveraging Europe's expertise to accelerate cell therapy for type 1 diabetes
- Establishing ortho and cardiology ambulatory surgical centres in Europe

Until now, the assessment of biobanks was organised differently across all medical centres with high administrative burden and time investment as investigators of multicentre biobanks often had to go through a different process at each centre, in which various documents were used.
